# **Seaplane Transfer Policy**

Trans Maldivian Airways (TMA) provides seaplane transfers to/from the TMA Terminal at the Velana International Airport (VIA) to coincide with the arrival/departure of international flights.

Please be informed that since this is a shared seaplane transfer, occasionally the seaplane may stop at other destinations while in route to and from our beautiful island. Kindly note that the seaplane journey takes approximately 25 minutes per way.

## **Baggage Allowance**

The standard included luggage weight in a seaplane is 25 kg, which includes 20 kg of checked-in luggage and 5 kg of hand luggage per person. Hand luggage is limited to one small bag of 5 kg (small ladies handbag / smallest size backpack / laptop bag). The weight for any bag should not exceed 32 kg and the linear dimension of any of the luggage pieces must not exceed 158 centimeters. The charge for baggage above the permissible limit is USD 5.00 per kg.

# **Seaplane Schedule:**

Seaplane Company provides a schedule one-day prior post 6pm Maldives time to flight date based on guest's international arrival/departure flights.

Kindly note that the hotel does not hold any control on the schedule.

#### **DOMESTIC CONDITIONS**

## **Domestic Transfer Policy**

FlyMe and Manta Air provide domestic transfers to/from the Domestic Terminal at the Velana International Airport (VIA), to connect with the arrival/departure of international flights.

Domestic transfers include 30 minutes flight from Velana International Airport to Dharavandhoo Airport and 25 minutes speedboat ride from Dharavandhoo to our resort. Please keep in mind that there could be a possible delay for various unforeseen events.

## **Baggage Allowance**

The maximum baggage allowance per person is 25 kg (20 kg check-in and 5 kg hand luggage) for passengers 2 years and above. Excess baggage will be charged an additional fee of USD 5. per kg payable at the domestic flight operator's counters.

### **Domestic Transfer Schedule:**

Domestic transfer schedules are subject to change depending on the airline's operations and informed to the hotel one-day prior post 6pm (Maldives time) to the flight date.

Please contact the resort to get the available transfer options.

# In addition, to facilitate smooth arrival in the Maldives, may we please request you to kindly have the below mandatory information/procedures followed:

- · All travelers to/from the Maldives, including tourists, visa holders, and Maldivians are obliged to submit the Traveler Health Declaration within 24 hours prior to their travel to obtain QR code on imaga.immigration.gov.mv
- · Effective from O5<sup>th</sup> March 2022, all arriving tourists and other visitors (traveling for the short-term and not subject to 07 days quarantine) are not required to present COVID-19 negative PCR test results to arrive in the Maldives. However; as a precautionary measure for all arriving and inhouse guests and staff we request everyone to do a PCR test on the day of their arrival at the Resort at no cost.

While departing from the Maldives we can arrange for a PCR test. Our in-house doctor can take the sample at the resort and send it to Male' hospital 72 hrs. prior to guest departure and will get the result on departure day and the same will cost USD 120 plus 23.2% taxes per person.
